AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Program operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the United Schools Insurance Program from September 1, 2019 through August 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Program's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2021 and 2020, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement professional services
- General disbursements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress and solvency compliance

INFORMATION ABOUT THE PROGRAM

The Eastern Washington School District Insurance Group was formed through an inter-local agreement in 1985 to allow the joint purchase of insurance, joint self-insuring, joint hiring or contracting for risk management services and purposes, and claims administration. On March 15, 2004, the group changed its name to the United Schools Insurance Program. As of the end of fiscal year 2021, the Program had 155 members.

An elected, nine-member Board of Directors governs the Program. Board Members serve staggered, three-year terms. The Program has no employees, but contracts with a private firm for claims administration and risk management services. For fiscal years 2020 and 2021, the Program operated on annual budget of approximately \$18.6 million and \$20 million, respectively.
